CHAPTER -III

Now, THEREFORE, this DEED OF TRUST declares and WITNESSETH AS FOLLOWS:-

1. The name of this Trust shall be " ISLAHI CHARITABLE TRUST "

CHAPTER -IV

AREA OF OPERATION AND TRUST OFFICE

1. The Trust shall function within Kerala State.
2. It shall be lawful to the board of Trustees to extend the area of its operation to any other states in India.
3. The office of the Trust shall be situated at Hosangady in Manjeshwar of Kasaragod District, Kerala State.

CHAPTER - V

AIMS AND OBJECTIVES

1. To establish and manage public schools with or without the aid of government and admit students with special reference to children of poor and down trodden parents/guardians and those persons who are deprived of educational facilities.
2. To establish and maintain public hostels for the purpose of assisting. Children of poor and downtrodden parents/guardians and those persons who are deprived of educational facilities.
3. To establish and manage Hospitals, Medical Colleges and Research Centers for the welfare of general public.
4. To start and manage Job Oriented Courses and Self Employment Training Centers for both educated and uneducated Youths and exploring the possibilities of their employment opportunities.
5. To impart education and training to physically handicapped and mentally disabled people.





6. To establish and manage orphanages, Hostels for widows and old age people and provide food and clothing.
7. To run an orphanage and give the best modern and moral education to the most neglected class of the society.
8. To educate and assist in wide publicity and also to assist the Government sponsored programs on eradication of epidemic diseases like Leprosy, Cholera, Polio and Chicken Pox including Vaccination with special reference to the Rural Mass and also taking preventive steps about AIDS, CANCER and Tuberculosis.
9. To establish Financial Institutions and give the interest free loan for the economic development of people.
10. To educate the general public regarding dangers of Terrorism and Communalism and propagate peace in the society.

12. To provide assistance to social forestry programs and make awareness among people in preservation of water and environment.

14. To establish prayer halls for the spiritual welfare of people.
15. To construct commercial building and there by create permanent source of income for the achievement of the Trust's objectives.
16. To promote culture and languages by conducting study class, seminars and public talks.
17. To eradicate social evils like consumption of alcohol, tobacco and drugs etc.

18. To provide interest free financial assistance for education and needy people.
19. To take over and run any existing institutions run by any person, society or other trust.
20. To do such other activities as may be decided by the Board of Trustees for the welfare of general public.
21. To assist and donate funds to other charitable institutions having similar objects.

In furtherance of the above-mentioned aims and objectives the Trust shall be entitled:

- a) To invest and deal with the funds of the Trust as per the decisions of the Board of Trustees from time to time to attain the objectives of the Trust.
- b) To sell, improve, manage, develop, mortgage, lease or otherwise deal with all or any part of the property or properties of the Trust.
- c) To obtain and accept subscriptions, donations, grants gifts bequests and Trusts from any person or persons, firm or corporation or other body or bodies.
- d) To obtain and accept donations from Non Resident Indians, Non Resident Expatriate and foreign nationals.
- e) To purchase, acquire, own or obtain on lease, hire or exchange any movables or agricultural or non-agricultural immovable properties for the achievement of any of the objectives of the Trust.
- f) To engage the teachers both Arabic and modern education, Imams and necessary staff for the maintenance of the Trust, Mosque, Madras, schools or any of the Institution maintained by the Trust.

- i) To open mosques, Arabic schools, craft schools, quarters for staff members and for this to construct new buildings.
- j) To negotiate with Panchayat, Municipality, University or other public or private bodies and also with Government and other authority for promoting or expanding the aims and objectives of the Trust.
- k) To use all income derived from the properties movable or immovable of the Trust for the furtherance of the objectives of the Trust.
- l) To make rules and regulations and bye-laws for the conduct of the Trust and its various activities as decided by the Board of Trustees.
- m) In general to do all such other things as are incidental, necessary and conducive, for the attainment of the above aims and objectives of the public.

FUNDS AND PROPERTIES OF THE TRUST.




The funds and properties of the Trust shall comprise of:


5. Movable and immovable properties acquired by the Trust.

CHAPTER- VII


BOARD OF TRUSTEES

1. The above mentioned Nineteen Trustees form the Board of Trustees whose names are given in chapter I, and they be the Trustees for life.
2. According to the circumstances and necessity of occasion as felt by the Board, the Trust is empowered and authorized to enlarge its strength by nominating members from outside as it feels necessary subject to the condition that the total number of Trustees should not exceed Twenty Five and such nominations shall be supported by 1/3 of the Board of Trustees.
3. The Board of Trustees shall have a Chairman, one Vice-Chairman, a Managing Director, and a Treasurer and such other office bearers is may be created by the Board of Trustees from time to time for such period as deemed necessary.
4. The Board of Trustees in the Board meeting may appoint office bearers from the Honorary Trustees who are necessary for assisting Chairman, Vice Chairman, Managing Director and Treasurer.
5. The above-mentioned office bearers shall be elected at the first meeting of Board of Trustees.



CHAPTER - VIII

POWERS OF THE BOARD OF TRUSTEES




Without prejudice to the generality of powers vested in the Trustees, but in accordance with the provisions of the Indian Trust Act 1882 and also subject to the provisions of the Income Tax Act 1961 and Income Tax Rules 1962, the board of Trustees shall have the following specific power: -

1. To acquire by purchase, gift, grant, exchange, lease, hire or otherwise properties of all kinds, including movable and immovable properties both agricultural and non-agricultural and to improve and add to the corpus of the Trust, finance and property subject to the terms and conditions as may be decided by the board of Trustees.
2. To acquire or construct buildings or purchase properties and to rent out the same and to have income for the trust.
3. To invest money of the Trust in such investments for the betterment of the Trust.
4. To receive any money from the public and to issue receipt.
5. To enter into any compromise and refer to any matter under arbitration.
6. To appoint or engage the service of any person or other staff found necessary upon such remuneration and terms as the board of trustees may deem fit.
7. To take disciplinary action against the employees of the Trust and also to terminates their services.
8. To incur all costs and expenses considered by the board of trustees to be necessary in connection with the affairs of the Trust and future efficient management of the affairs and properties of the Trust.
9. To open account in such bank as the Trustees may deem fit and to operate upon such account jointly or as decided by the Board of Trustees.

10. To borrow or raise any money with or without security from the Banks, financial institutions.
11. To manage and control the properties and affairs of the Trust.
12. To do all other acts, deeds, matters and things which the Board of Trustees deem fit and necessary for carrying out the aims and objectives of the Trust.
13. The Board of Trustees may delegate any one or more of the powers enumerated above to one or more of the Trustees as deemed fit from time to time.

CHAPTER - IX
POWERS AND FUNCTIONS OF THE OFFICE BEARERS

1. CHAIRMAN:

- a) He shall preside over all the meetings of the Board of Trustees.
- b) He shall have general control over all the affairs of the Trust properties and the institution under its control and its employees.
- c) The chairman shall have every power to take emergent decision at appropriate time in the interest of the Trust and he shall have the full control of the entire staff members.
- d) The Chairman has every right to operate the Bank account along with the Treasurer or Managing Director.




2. VICE CHAIRMAN:

- a) In the absence of the Chairman, the Vice-Chairman shall assigned to him by the Board of Trustees from time to time preside over the meetings and act all the powers of the Chairman by taking written consent of the Chairman.

3. MANAGING DIRECTOR :

- a) He shall be in charge and responsible for the safe custody of all the records and documents relating to the Trust and its properties.
- b) He shall convene meetings of the Board of Trustees in consultation with the Chairman and maintain regular records of the proceedings of such meetings and also place budget for approval of the Board of Trustees.
- c) He shall be the custodian of all correspondence and all financial statements and returns required in connection with the management of the Trust.
- d) He shall implement all resolutions of the Board of Trustees unless otherwise decided by the Trustees.
- e) He shall also carry out such other responsibilities and duties entrusted to him from time to time by the Board of Trustees.
- f) He is authorized to keep with him an amount not exceeding Rs.50,000.- (Rupees Fifty Thousand only) or day to day expenditure required for the Trust.
- g) The Managing Director shall place the yearly account before the auditors in the trust for verification and auditing the same.
- h) The Bank account shall be operated by the Chairman along with the Managing Director or Treasurer.


4. TREASURER:

- a) He shall maintain or cause to be maintained regular books of accounts of the Trust.
- b) All legacies, donations, subscriptions, shall be paid to the Treasurer whose receipt shall be valid and binding on the Trust.

- c) He shall have the accounts of the Trust audited by a chartered Accountant as decided and approved by the Board of Trustees.
 - d) The accounts of the Trust in bank/s shall be operated in the manner decided by the Board of Trustees and the Bank account shall be operated by the Chairman along with the Treasurer or Managing Director.
5. If any of the said office bearers of the Trust resigns for his post or any of such posts lies vacant for any other reason, the same shall be filled up by passing a resolution of the Board of Trustees at a meeting supported by 1/3rd of the total No's of the Trustees present and voting.

CHAPTER - X

CESSATION OF TRUSTEESHIP


The Trusteeship shall cease:

1. By death of the Trustee or
2. By resignation accepted by the board of Trustees or
3. By any Trustee becoming bankrupt, lunatic or is convicted of any criminal offence involving moral turpitude or
4. By expulsion as per Chapter XI.

CHAPTER - XI

EXPULSION

If any of the Trustee found immoral or his conduct inside or outside the Trust is found detrimental to the interests or reputation of the Trust, or if he behaves in manner prejudicially affecting the Trust and its institution and activities, he shall be liable for expulsion from the Trust, by a resolution passed by at least 2/3 Trustees present at a meeting of the Board of Trustees. However if a Trustee is outside India he may record his opinion by writing a letter duly signed by him and the same letter should be presented in this meeting.

CHAPTER - XII


MEETINGS OF THE BOARD OF TRUSTEES AND NOTICE OF MEETING.

1. The Board of Trustees shall meet at least once in a month or as often as possible to transact the business of the Trust, at the office of the Trust, or at such other place and at such time to time determine.
2. Five Trustees or more, may in writing sent a requisition to the Managing Director to convene a Special Meeting of the Board of Trustees clearly indicating the subject matter to be discussed at such a special meeting and the Managing Director thereupon shall call a meeting by giving 3 clear days notice to the Trustees.
3. Three clear days time shall be given for a meeting of the Board of Trustees.
4. In case of emergency however meeting can be convened at short notice by the Trust.
5. The mode of sending notices shall be determined by the Board of Trustees from time to time.

CHAPTER - XIII

QUORUM OF THE MEETING

The quorum of the meeting of the Board of Trustees shall be 1/4th of the Board of Trustees except for the special quorum mentioned in this Deed.

CHAPTER - XIV

VOTING

All questions before the Board of Trustees shall be decided by a majority of votes, unless other method is mentioned in this Deed of Trust and in case, there is equality of votes, the Chairman or any one presiding at the meeting shall be have a casting vote, in addition to his own vote.

CHAPTER - XV

AMENDMENTS TO THE DEED OF TRUST

The Board of Trustees, by its resolution, attended in person by two third of the total members at a special meeting of the board of Trustees reserve the power to amend, modify, delete or alter this Deed of Trust, its aims and objectives so as to bring out the intention, if the same have not been expressed clearly and correctly in the text of this Deed of Trust.


But No amendments to the Trust Deed shall be made which may prove to be repugnant to the provisions of Sections 2(15), 11, 12 and 13 and 80G of the Income Tax Act. 1961 as amended from time to time. Further no amendment shall be carried out without the prior approval of the Commissioner of Income Tax.

But such change or alterations amendment, deletion etc., should not alter in any way the nature or character of the Trust, and that neither the Authors nor the Trustees shall have any power to revoke the objectives of this Trust at any time.




CHAPTER - XVI
GENERAL

1. If the services of any persons are found beneficial to the Trust, he may be co-opted as **Honorary Trustees** for such period as the Trustees deem fit, or invite for any particular meeting of the Trust for his help, opinion or advice, but he shall not be entitled to vote.
2. All the Trustees shall be the life members.
3. If any vacancy arises in the Board of Trustees, due to resignation, or for any other reasons enumerated in Chapter X, the same shall be filled up by passing a resolution of the Board of Trustees at a meeting supported by 1/3rd majority of the Trustees present and voting.
4. In case of Death of a Board of Trustees, his nominee will be selected as Board of Trustee with a condition that nominee must be the follower of Islam according to Quran and Sunnah. The same selection must be passed by a resolution of the Board of Trustees at a meeting supported by 1/3rd majority of the Trustees present and voting.
5. All the deeds and other documents to be executed by or on behalf of the Trust shall be done by the Chairman of the Trust and the Trust may use or be used jointly in the name of the Chairman and Managing Director of the Trust.
6. The office bearers of the Trust shall hold office for a period of Five years.
7. All office bearers who have held office once are eligible for re-election.
8. The office bearers elected for the terms after the expiry of their term shall continue in office till the election of fresh office bearers.
9. At meetings, ordinary or special only subject mentioned in the notice shall be discussed and decided. However any other subject can be discussed only after the subject mentioned in the notice is discussed and if the Chairman is approved for the same.

10. For any urgent business connected with any affairs of the Trust, the office bearers may meet as and when required under the directions of the Chairman of the Trust and take such decisions as may be necessary.
11. There shall be maintained all accounts of the Trust regularly. The accounts shall be duly audited by a Chartered Accountant. Every year the accounts shall be closed by 31st March.

CHAPTER - XVII DISSOLUTION OF TRUST

In case of dissolution of the Trust for any reason, the properties of the Trust will never be distributed among the Trustees or members of Managing Committee or Government Body. It is further made clear, that if for any reasons, the objectives for which the Trust has been created cannot be achieved or fulfilled and consequently the Trust cannot function and or the Institutions started by the Trust can not be run efficiently for any reason whatsoever, then, the Board of Trustees by a majority of 2/3rd of its members present at a special meeting convened for this purpose, all assets remaining shall be transferred to any of Charitable Trust having similar objects and aims which enjoys recognitions under section 80G of Income Tax Act 1961, run under Kerala Nadwathul Mujahideen (Regd.No.2/1957) Calicut, Kerala.



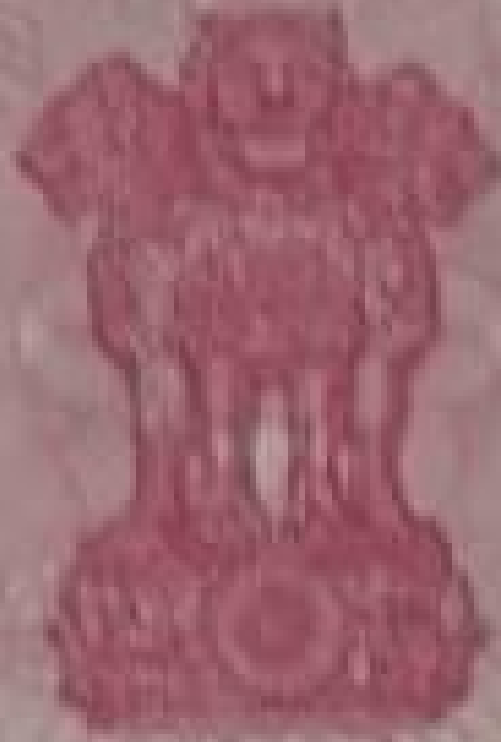


